APPROVAL OF MINUTES

A motion was made by Mr. Schul, seconded by Ms. Kerek, to approve the minutes of the November 10, 2021 regular monthly meeting. Motion carried.

UNFINISHED BUSINESS

- a. Ordinance #A-1060 –2nd reading. Same tax rate and breakdown as last year, 10.5 Mils. Ms. Clabaugh made a motion and it was seconded by Mr. Schul to approve the ordinance fixing the tax rate for 2022. Motion carried.

It must be complete within 3 years.

Office – Mr. Payne stated we received the check from the county for the Act 52 grant for the demolition of 407 Chase Street. Mr. Payne also stated that he put in a bid of \$250.00 each for the 2 properties currently in repository, which would make two lots that the Borough would own. The office server crashed and had to be repaired and moved to Ms. Brinkley's computer.

Solicitor – Mr. Alfieri reported forwarded the Police Contract to the Police for their review.

Police Department — Chief Boyer stated that there has been a new telephone scam reported where people are pretending to be an old neighbor claiming they were used as a loan reference. The new Explorer is fielded despite the delays with the computer and printer. The old method of ticketing etc. will be used until the computer is installed. Chief Boyer also asked that the 2015 Explorer be placed up for municipal bid and removed from service.

Mr. Kase thanked Cody Scalise for his service on the board, as this is his last meeting. Mr. Kase also added information on the "Hunters Sharing the Harvest" Program which allows hunters to donate venison to be given to a needy family in the community.

Mr. Schul added that our representative Don "Stretch" Reed of Emporium lost his wife.
